REGISTRATION OF CANDIDATES FOR THE JUNE 2025 UHPAB SEMESTER ASSESSMENT

To: All Principals of Health Training Institutions (HTIs) in Uganda

This Circular follows the enactment of the Technical Vocational Education and Training (TVET) Act 2025 and the gazette of Statutory Instrument No. 25 of 2025, that merged the Uganda Allied Health Examinations Board with the Uganda Nurses and Midwives Examinations Board. The Act established the **Uganda Health Professions Assessment Board (UHPAB)**, responsible for the Assessment and Certification of health professionals under Technical and Vocational Education and Training. This implies that all Trainees undertaking Allied Health, Nursing and Midwifery programs at Diploma and Certificate level in Uganda shall be assessed by UHPAB following the same Assessment Policies, Rules, Regulations, Standards and Guidelines.

This Circular therefore is to communicate to you the guidelines that shall govern the registration of candidates for the June, 2025 UHPAB Semester Assessment.

- All eligible candidates shall be registered with UHPAB for Assessment by the respective Training Institutions from 14th April to 9th May, 2025. There will be no extra time allocated to late registration of Trainees.
- 2. In the interim, the assessment fees shall not change and therefore will be maintained for all Allied Health, Nursing and Midwifery programs;
- 3. In the interim, all Allied Heath Training Institutions shall pay assessment fees to Uganda Allied Health Examinations Board Stanbic Bank account, William Street Branch, Account No. 9030006288935, while Nursing and Midwifery Training Institutions shall pay the Examination and NSIN fees to Uganda Nurses and Midwives Examinations Board Stanbic Bank account, Nakasero Branch, Account No. 9030006976351 until such a time when UHPAB Bank account shall be fully operational;
- 4. In the interim, all Allied Health Training Institutions shall register candidates for Examinations, using the following registration link:- 165.232.131.154/schools



while Nursing and Midwifery Training Institutions shall register candidates using the following registration link:- 41.186.86.12:8008;

- The Nursing and Midwifery Trainees admitted in January, 2025 shall upon successful verification by Ministry of Education and Sports (MoES), apply for Nursing Student Identification Numbers (NSIN) through their respective institutions, after payment of Uganda Shillings twenty thousand only (Ugx.20,000) and related Practical Logbook fees from 14th to 22nd April, 2025;
- 6. In the interim, all Nursing and Midwifery training Institutions with candidates admitted in January, 2025 shall take passport photographs of such candidates for upload during their registration;
- 7. The training Institutions Shall collect the Practical Logbooks on the 29th to 30th April, 2025 from UHPAB Secretariat (former UNMEB Head office) on Plot 157, Ssebowa Road Kiwatule from 9:00am 4:00pm. All Trainees must attend their respective practicum/Clinical placement prior to siting of their Examinations;
- **8.** All payments shall be verified by the Finance and Administration Department before issuance of Registration slots and payment receipts;
- 9. All Trainees admitted before the enactment of the TVET law, shall continue abiding by the Examination rules and regulations stipulated upon their admission, Practical Logbooks and Academic Research Guidelines;
- 10. All Trainees shall maintain their Registration/Identification numbers for Allied Health Programs and NSIN numbers for Nursing and Midwifery Trainees;
- **11.** All Trainees should be registered in time to allow for timely preparation for the forthcoming June, 2025 Assessment.

More guidance will be issued from time to time.
